## *"Key findings from Oliver Wyman's inaugural Women in Financial Services Report"*

Oliver Wyman's aim in producing this report was to move beyond individual experience and anecdote to explore the questions: What stops women getting to the top in financial firms? And how can the industry improve?

In preparing the report, the gender mix of senior staff at over 150 firms was analysed, whilst over 1,000 current and potential financial services employees from five countries were surveyed and over 60 senior women (and a few men!) from across the sector were interviewed. 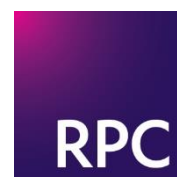
