"Female offenders - should they be treated the same as their male counterparts?"

It is the first national radio station for prisoners in the world. She also founded the Make Justice Work Campaign. She is currently a criminal justice advisor and is chair of Spark Inside and Women's Breakout and a trustee of the Comedy School. Roma has been working on behalf of offenders since 1993, having previously worked for Contact a Family.

Roma will be talking to us about issue of women and girls in the criminal justice system and why the public believe that male and female offenders should be treated in identical ways, despite their biological and social differences; why they don't understand the social factors that shape women's experiences and don't understand the harmful effects on women in particular.
