*“Emerging Risk Analytics”*

Neil is a principal and consulting actuary with Milliman where he leads the development of Milliman's CRisALIS methodology for analysing and quantifying enterprise risk. Prior to joining Milliman, Neil spent 15 years working in the UK operation of a Top 10 insurance company in Europe. For five years, he sat on the company board and had executive responsibility for strategy, legal, compliance, projects, marketing, product development, public relations, mergers and acquisitions, finance, and risk management.

This session looks at a case study which uses advanced machine learning algorithms, such as deep neural networks, to analyse social media conversations about Brexit. The purpose of the study was to examine whether useful information could be extracted from social media in what is effectively real time on a key topic in a political economy.

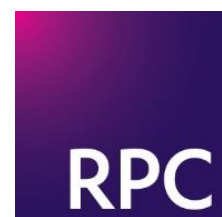
