Before joining Swiss Re, Nick worked at Aviva plc as head of Regulatory Policy Oversight and Economic Capital Integration and at the UK Financial Services Authority (now the Prudential Regulatory Authority) as a member of the General Counsel Division and manager of group prudential policy.

In his roles, Nick has participated a number of industry bodies, particularly the CRO Forum (www.thecroforum.org). At the CRO Forum, Nick led the work on cyber risk from 2014 to 2018 including publication of three papers on the management of cyber risks and resilience.

Nick started his career at Berwin Leighton Paisner and is a qualified solicitor.
