# "The Building Safety Act – Addressing Safety in the UK Construction Industry"

The Grenfell tragedy in 2017 brought into sharp focus issues with the quality of residential properties built in the UK, particularly with fire safety. As thousands of homes have needed remediation, so thousands of homeowners have found themselves trapped in properties they can no longer afford and also cannot sell. Alexandra Anderson will be talking about the UK Government's response to this crisis, the Building Safety Act 2022, discussing the new regime for the construction of high risk residential buildings and who will now pay to remediate properties built in the past.

Alexandra is an insurance lawyer with a wealth of experience in defending claims against construction professionals and surveyors. She also sits as a Deputy District Judge.
